1. Shipments via Fairexx German advanced warehouse (Applicable for EU-Exhibitors)

A. ROAD- & COURIER-CARGO – INBOUND (1 CBM = 333 KGS)

Transport from Fairexx-advanced warehouse-Germany up to stand-Edinburgh (incl. registration, storage, handling). Customs formalities under section 2. Overtime surcharges under section 7 apply.

A. AIR CARGO – INBOUND (1 CBM = 333 KGS)

Transport from London Heathrow airport up to stand-Edinburgh (incl. airport-THC, handling and transit to UK advanced whse., storage, transfer to venue-Edinburgh, delivery to stand). Overtime surcharges under section 7 apply.
