

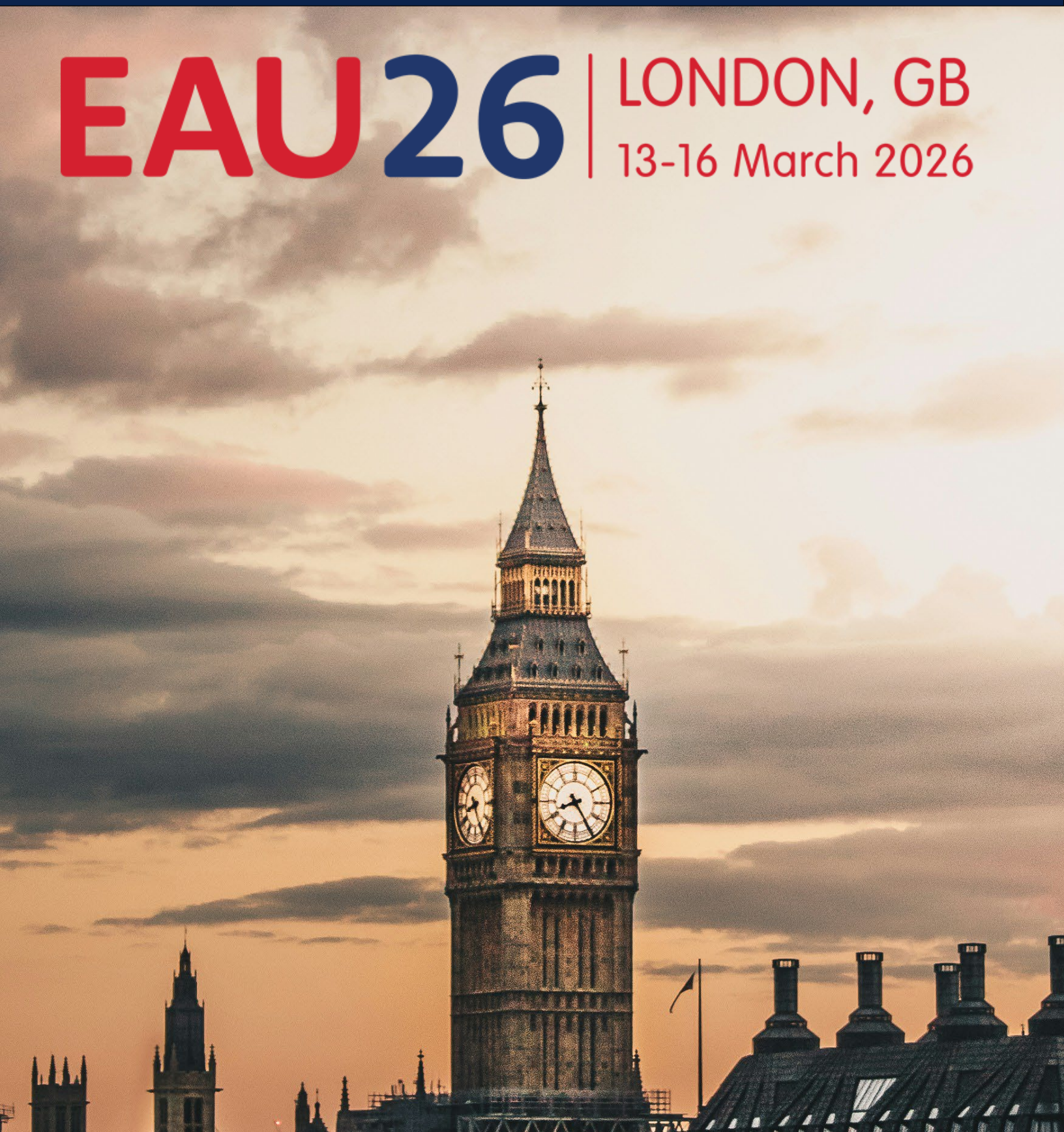

# 1. SHIPMENTS ORIGINATING FROM OUTSIDE THE UNITED KINGDOM

(ie. Continental Europe, United States, Canada, Switzerland, etc.)

## 1.1 Courier shipments

Send via FEDEX, DHL, UPS, TNT (and other courier companies)

Courier companies cannot make customs clearance as they lack an Importer-Record-Number.

Shipment for temporary importation via ATA-Carnet and/or via commercial invoice (goods that will be returned after event) **must** be sent by airfreight (please see column 1.2) as courier companies cannot arrange any temporary customs clearance.

We strongly recommend sending your courier shipments to our warehouse. We cannot guarantee an on-time delivery to the exhibition booth in case your shipment arrives later than **2<sup>nd</sup> March 2026**.

### IMPORTANT NOTE:

We strongly recommend exhibitors not to send courier shipments directly to the venue/stand in London. Courier companies cannot do a customs clearance as they will need a local importer.

For shipments sent directly to the stand and stuck in customs no liability is accepted.



## 1.2 Airfreight

Your shipment should arrive at Amsterdam airport (AMS) no later than **2<sup>nd</sup> March 2026**.

**The goods will be automatically forwarded to the venue in London.**

We kindly ask you to send us a pre-advice at least one day before departure including a copy of the airwaybill and a copy of the commercial invoice/packing list.

## 1.3 Documentation

For shipments outside of the European Union, we require the following documents for the customs clearance:

- proforma invoices/packing lists in English addressed to EAU 2026 exhibitor name, booth number, showing weights/sizes, HS codes and values with exact description of the goods
- Separate invoices for temporary importation (exhibits) and permanent importation (consumables, brochures etc.)
- Serial numbers and pictures of every item that needs to be imported temporarily
- If necessary: Certificate of Origin (Form A/EUR.1)
- If necessary: special certificates (health/veterinary)

All exhibits/material entered under temporary importation are subject to control and examination by EU customs for inward and outward movements.

Any exhibits remaining in the EU after closure of the exhibition are subject to duties and/or taxes. Payments must be guaranteed prior to removal of goods from the Exhibition venue.

Any shipments arriving after our deadlines that require customs clearance will be subject to a late arrival surcharge of 25% on our official handling rate.



## 2. SHIPMENTS ORIGINATING FROM THE UNITED KINGDOM

### 2.1 Groupage roadcargo, courier shipments (DHL, FedEx, UPS, etc.)

We strongly recommend sending your groupage or courier shipments to our warehouse. We cannot guarantee an on-time delivery to the exhibition booth in case your shipment arrives later than

## 4. MARKING OF PACKAGES

Please number every package consecutively and make sure that the following information is indicated on every package:

We kindly ask you to use safe and strong packing material which is strong enough to be re-used after the event.

## 5. INSURANCE

We strongly recommend to all exhibitors to arrange for an insurance cover to include transit to and from the exhibition, whilst on display and in storage. Please contact us for further information and rates.

## 6. PAYMENT

All shipments are subject to payment before delivery to the booth.

We accept the following payment methods:

- **Bank transfer:** please provide us with a copy of the transfer statement
- **Credit Card:** please provide us in advance with your credit card details (not for customs expenditures unless with an additional 5% service fee)
- **Cash:** all major currencies are accepted

## 7. TERMS AND CONDITIONS

All work undertaken is subject to the Dutch Forwarders terms and conditions Fenex, latest version, in conjunction with the conditions and rates for trade fair transportation. A copy will be sent on request.

The responsibility and liability of FAIREXX Logistics for Exhibitions BV as Fairs & Exhibitions forwarder, ends once the goods have been delivered to the stand, irrespective of exhibitor's or his representative's presence on the stand

When written instructions fail, goods may be delivered to the stand commencing on the first day of the official build up period.

The responsibility and liability for return freight at the close of the exhibition starts only with the collection from the stand during the official dismantling period. The surrendering of documents by the exhibitor at the Fairexx office and the acceptance of same does not constitute any admission of responsibility or liability for freight which has not yet been collected from the stand. If the exhibition booth has been left, without the shipment being collected by us, shipment remains on the booth at exhibitors risk.

Externally recognisable damages must be stated on the work order / delivery order on delivery of the goods. Any claim can only be treated when made in writing and presented at our on-site office. Verbal claims only will not be accepted.

Our invoices will be due immediately after issuance without any further notice. Customers not known to us or with whom we have not agreed any terms of payment, will be asked to pay our invoice(s) before the event starts or on-site during the event or before return shipping of their exhibits.

## 1. DIRECT DELIVERIES TO AND FROM VENUE LONDON

### A. Full and part trailer loads

Unloading/reloading trucks and direct delivery to/pick up from stand via 3.0-to forklift. Overtime surcharges under section 6 apply.
